### Job Responsibilities

### Responsibilities include but are not limited to the following:

Supervising and guiding the residents to whom (s)he is assigned, including:

- Responsibility for guidance and supervision of children in The Lampstand's care
- Overseeing physical care of residents
- Development of acceptable habits and attitudes
- Management of resident behavior through behavioral support program
- Conduct emergency intakes
- Helping the resident strengthen her capacity to function productively in interpersonal relationships
- Helping to meet the goals and objective of all Service Plans
- Maintain accurate and organized documentation implementing new systems when directed by management
- Maintain confidentiality of information and protect anonymity in survivor relationships
- Implement program objectives and performance standards as directed by management
- Regular and predictable attendance
- Participate effectively as a team member through communication, cooperation, information sharing and problem solving
- Provide support to the operations staff as directed
- Participate and pass all staff trainings and programs as required
- Any other tasks or duties as assigned
- Maintain healthy boundaries with clients



- Participate effectively as a team member through communication, cooperation, information sharing, and problem solving
- Observing staff in their day to day basis, supporting direct care staff on the floor, during transports, and during special on and off campus activities
- Inspect the home weekly for compliance
- Meet with staff individually to discuss areas of improvement

- Ability to interact effectively as a team member and independently with shelter staff and residents.
- Satisfactory preliminary criminal history background check and clean motor vehicle record determination as required by law
- A personal history of never having been shown by credible evidence (such as a decision
  of a court or jury, or a department investigation or other reliable evidence) to have
  abused, neglected, sexually exploited, or deprived a child or adult or to have subjected
  any person to serious injury as a result of intentional or grossly serious injury
- Documentation of at least two professional, educational, or personal references that attest to the person's capability of performing the duties of the position and to the person's suitability of working with or around children
